PERSONNEL AND TRAINING

Our security team is self-motivated, diligent and well-disciplined personnel who are mostly Ex-service commissioned and non-commissioned Officers. All new recruits undergo stringent training in the following areas to make them competent and effective in carrying out their duties.

- (a) Securing premises, establishments and factories effectively and also provide security to individuals

- (c) Training in Electronic/CCTV walk through metal detectors
- (d) Procedures on powers of arrest by security staff

In addition to training in general duties our security personnel are given a comprehensive training in the following specialized areas at the time of recruitment.

Explosives	: -	Identification of explosives, Improvised Explosive Devices (IEDs) Follow up action to be taken on detection of explosives /IED's / etc.
Public Relations	:-	Special Programmes to train all aspects
First Aid	:-	Training of safety methods and First Aid

DEPLOYMENT / SUPERVISION AND CONTROL

A Sector Manager would be appointed who would be responsible to visit the site 04 times during day and twice during night per week.

Manager Operations in charge of the area will visit/meet the Client once a month, and provide a feed back to the Management with regard to performance/ lapses etc.

Our rates are based on the Wages Board Ordinance for security rates VAT and any other statutory levies imposed by the Government of Sri Lanka. We have also obtained approval for Ministry of Defense annual licenses.
